Powers of the State Service of Ukraine on Food Safety and Consumer Protection

- ☐ State control (supervision) over control bodies and operators
- ☐ Sending a reasoned written request to the Ministry for Development of Economy, Trade and Agriculture of Ukraine about exclusion of a certification body from the Register of Certification Bodies or about exclusion of an operator from the Register of Operators
- ☐ Participation in regulation drafting
- ☐ Others

Requirements to the List of foreign certification bodies (competence of the State Service of Ukraine on Food Safety and Consumer Protection)

Importer or exporter shall submit to the State Service

An application, in no particular format, about the inclusion of the foreign certification body into the List of foreign certification bodies, including the information as follows:

name of the foreign certification body's state of incorporation

confirmation of accreditation of the foreign certification body in the respective field of organic production and/or circulation of organic products by the accreditation body of the foreign state which is a party to international or regional agreements on accreditation recognition

name of the authority that controls the foreign certification body

The State Service of Ukraine on Food Safety and Consumer Protection exercises control (supervision) in organic production, circulation and labelling of organic products

Announced and unannounced controls

The Law of Ukraine “On Food Information for Consumers”



- any food product intended for a final consumer or public catering facility has to be accompanied with the information about it as required by the legislation
- the information has to be accurate, reliable and clear to a consumer
